## **INFORMATION ON PERSONAL DATA PROCESSING**

In accordance with the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (hereinafter the "Regulation")

I am aware that due to my membership in the club

- I. the Administrator is obliged by sec. 3a par. 3 of the Act 115/2001 Coll., on support of sports, (hereinafter the "ZOPS") to process following personal data:
  - 1 first and last name,
  - 2 date of birth,
  - 3 current address and
  - 4 in case of foreigners, citizenship and the address where they mostly stay

(hereinafter "Personal Data").

- II. All Personal Data are processed for the purpose of registration of the members and of related activities (e.g. subsidy applications, assurance, etc.).
- III. I am aware that on the basis of sec. 3a par. 6 of the ZOPS, my Personal Data will be processed and stored in accordance to points 1 to 4 for 10 years, beginning the day on which I cease my activity for which I am registered by the Administrator.
- IV. I am aware that on the basis of legitimate interest of the Administrator, the Personal Data will be processed and stored for 10 years, beginning the day on which I cease my activity for which I was registered by the Administrator, for the purpose of registration of the members and related activities.
- V. I am aware that in case I refuse to provide the abovementioned Personal Data, I cannot become a member of the abovementioned club/team.
- VI. I am aware that the Administrator hands Personal Data to these Processors and Recipients:
  - the relevant sport union,
  - Executive Committee of the Czech University Sports Association, address Atletická 2417/1E, 169 00 Prague 6 (hereinafter "ČAUS"),
  - relevant institutions of national administration and self-governance,

for the following purposes:

- records keeping of the members of ČAUS on the basis of ČAUS directives and for related activities,
- identification of competitors,
- subsidy applications on the basis of sec. 6b ZOPS.

- VII. I am aware of my right to:
  - a. have access to my Personal Data (in accordance with art. 15 of the Regulation),
  - b. apply for them to be rectified (in accordance with art. 16 of the Regulation),
  - c. have Personal Data erased without undue delay if there are reasons as stated in art. 17 of the Regulation,
  - d. restrict processing of Personal Data in cases stated in art. 18 of the Regulation,
  - e. data portability in cases stated in art. 20 of the Regulation.
  - f. lodge a complaint with the Administrator in accordance with art. 77 of the Regulation.

I can apply these rights at any moment by contacting the Administrator at the e-mail address: sport@mup.cz.

- VIII. I am aware that my Personal Data can be handed over for processing within the European Economic Area (e.g. to processors). In accordance with law, my Personal Data can be also handed to countries outside of the European Economic Area.
- IX. Personal Data, which the Administrator is allowed to process, shall not be used for decision making on the basis of purely automated processing or profiling.
- X. In relation to my membership in the MUP Sport Club, I am aware that group illustration photographs or audio-visual records can be made at some sport events for the purpose of informing about activities of the MUP Sport Club on the internet and social networks.

I am aware that I am obliged to inform the Administrator about any change in the abovementioned Personal Data.
